#### **260/19 APOLOGIES**

Apologies for absence were received from Luke Tugwell, Colin King, Huw Wyn Jones and Derek Hainge.

#### **261/19 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION**

The Town Clerk declared an interest in item 8 and removed himself from the meeting.

#### **263/19 URGENT BUSINESS**

The Mayor advised the Council that he had received two significant letters since the last meeting:

- i) The first was in response to his correspondence to the loss adjusters, tasked with coordinating the demolition of 164 & 166 High Street, asking for the demolition to be expedited. The response was read out to the Council and, while it contained a breakdown of work undertaken, did not address the concern expressed as to the length of time the operation was taking and there was no estimate included as to how much longer until the High Street would be closed.
- ii) The Mayor has also received correspondence from Llandwrog Community Council, which has also written to every community council in Arfon. The letters request Bangor City's support in its call for Gwynedd Council to arrange an urgent discussion, with everyone with an interest, in the problems caused by tourists to Snowdonia National Park. It is felt that the region should be better prepared by the summer of 2021.

**RESOLVED:** For the Mayor to write to Gwynedd Council in support of Llandwrog Council's proposal.

#### **265/19 TO DISCUSS THE VISION OF BANGOR WORKSHOP**

The suggestions raised at the previous week's workshop (and subsequent observations) together with means of progressing them was explored at length. It was felt that these extensive proposals could be sub-divided into short, medium and long-term objectives.

**RESOLVED:** that the Mayor, Deputy Mayor and Clerk will meet to prepare a plan based on the results of the workshop. Additional comments will be welcomed for another week or so.

#### **266/19 PIER UPDATE & CAR PARKING CHARGES**

It was reported to the Council that phase 4 of the Pier renovations were progressing roughly on time and within budget. There had been a few minor setbacks in timing, but these had largely been made up and completion was still expected by the end of October. The cost of parking vehicles in the Pier car park was discussed.

**RESOLVED** to increase the car parking charged to £2 per day and £5 overnight.

It was also reported that a meeting of Pier kiosk holders and other interested parties, including the Bangor Pier Enterprise Group, was being arranged for the end of September, in Penrhyn Hall, with exact details to follow.

**267/19 OFFICE & CHAMBER I.T. UPGRADE.**

Proposals to upgrade the administrative office I.T., which is aging and out of support were discussed, as was the upgrading of the Council Chamber I.T. to facilitate greater use of technology for Council meetings and other users.

**RESOLVED:** to accept the best value from three 'like for like' quotation to upgrade the Council's I.T.

**268/19 STAFFING PANEL**

The Town Clerk declared an interest in item 8 and removed himself from the meeting.

The procedures for advertising, short-listing and interviewing for the new position of City Director were agreed.

**269/19 FINANCIAL MATTERS**

i). Quarterly Account - for information

The City Council's quarterly accounts had been pre-circulated to Councillors. It was explained that the only budget line that had exceeded its budget was the grants awarded and this was due to the establishment and grants awarded by the Covid-19 Support Committee.

**RESOLVED:** To accept the quarterly account.

ii) Invoices for payment

It was noted that invoices as detailed on the schedule totalling £4,238.91 had been approved. **RESOLVED:** that the payments be noted.

**270/19 TO REVIEW & CONSIDER EXTENDING THE COVID19 SUPPORT COMMITTEE**

The council were appraised of the activities of the Covid-19 Support Committee, whose budget expired at the end of August and of the grants awarded. The possibility of extending the committee and increasing its budget for a further period was discussed.

**RESOLVED** to extend the Covid 19 Support Committee and the monthly budget of £5,000 for an additional three months.
