41/25 PUBLIC PARTICIPATION: PRESENTATION BY YGC

At the end of last year, YGC delivered a presentation to the Council on the Construction (Design and Management) Regulations 2015 (CDM 2015), outlining the Council's statutory duties when works on the Pier are undertaken. The agreement with YGC to carry out exploratory and consultation works on the Pier is scheduled to commence before the end of this year.

Given this timeline, it was considered appropriate for YGC to provide a further presentation to update the Council on their planned exploratory activities. The Council was advised that once these works are completed, YGC will prepare a condition report, which will be presented at a future Council meeting. This report will support the Council in developing a long-term, 20-year maintenance plan and in planning the next phase of restoration works required to safeguard the future of the Pier.

43/25 CITY DIRECTOR'S REPORT

The City Director highlighted a few points from his report, including:-

i) With our celebratory year drawing to a close, the City Council, in conjunction with Bangor University Education Department, will shortly be launching the Bangor Heritage College. This initiative, geared to junior school pupils, will emulate the

University format of students choosing a module to study. Currently, there are 37 modules prepared, each of ten questions. The uniqueness of this College is that every module is based on Bangor. The pupils completing the most modules will be invited to a 'graduation-style ceremony in the University's main PJ Hall.

- ii) Last month the Staffing Committee appointed a Deputy City Director, who took up her post on the 1st November. I am sure you will want to join me in welcoming Lisa to the team.
- Since our last meeting, the Mayor and I attended the first ever Bangor Day in Parliament, where we met a host of varied and interesting people, from Civic Servants, Ministers and businesses people. The objective was to celebrate Bangor 1500 year history and to shine a spotlight on the City.

They requested financial assistance from the Council with their current efforts, raising money to send to Jamaica to assist with the devastation caused by Hurricane Melissa at the end of October and the beginning of November this year.

IT WAS RESOLVED: To provide £2,000.00 of assistance for the current North Wales Jamaica Society Hurricane Appeal.

47/25 TO RESPOND TO THE BANGOR FIRST (formerly BID) RENEWAL VOTE

A short discussion was held by the Council on this item. The Chair told the council that there were three options when it came to voting on this item. Option one was to vote in favour of the continuation of Bangor First (Bangor BID) for the next 5 years, Option two was to abstain from voting and Option three was to vote against the renewal of the BID.

IT WAS RESOLVED: that the Council rejects the renewal of the Bangor First (Bangor BID) for the next 5 years.

48/25 TO DISCUSS A RESPONSE TO EXTEND THE BANGOR PUBLIC SPACE PROTECTION ORDER

A proposal from Cyngor Gwynedd was put forward to extend the public space protection order. The Council was informed that Cyngor Gwynedd was keen to consult with the local community and Bangor City Council on the intention to extend the Order for a further 3 years.

IT WAS RESOLVED: to support Cyngor Gwynedd in the extension of the public space protection order for Bangor.
