174/15 APOLOGIES

175/15 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

176/15 URGENT BUSINESS

The Town Clerk reminded Members that a Special Meeting of the Committee would be held on February 8th to discuss the Budget for 2016/2017 and the setting of the annual Precept. Budget books were being circulated and he asked that if there were any detailed questions these could be forwarded as soon as possible in order that a full and informative answer could be researched.

The Committee re-iterated the tribute paid earlier in the evening at the Planning and Amenities Committee in respect of the sad death of Former Councillor Eddie Dogan. The Town Clerk was asked to contact the family with regard to Members' attendance at the forthcoming funeral.

177/15 NORTH WALES POLICE

The Chairman welcomed Temporary Acting Chief Inspector Brian Kearney and Temporary Inspector Andy McGregor. Mr Kearney gave an update on operations in and around Bangor and the wider arena of Gwynedd. He highlighted the successful Pubwatch Scheme and Shopwatch Scheme which had operated locally and had resulted in a decrease in the crime numbers. He also highlighted the use of CCTV which had been effective in deterring crime and an increased rate of convictions. Other initiatives were noted including those over the Christmas period, advice to the public on burglaries, anti-social behaviour, and the changes in the criteria for capturing crime figures.

Members asked questions in respect of

- begging problems
- late night licensing
- highways safety
- drugs use
- speeding and noisy vehicles
- pedestrianisation
- town centre nightlife at the weekend

Mr Kearney and Mr McGregor responded to individual questions as appropriate.

The Chairman thanked representatives of North Wales Police for their attendance and members generally showed their appreciation.

180/15 CONSULTATION ON THE DRAFT LOCAL GOVERNMENT (WALES) BILL

Members noted that the Town Clerk had drafted an initial response on behalf of the City Council which had previously been circulated by e-mail. It was further noted that a workshop would be held on this subject matter at Venue Cymru, Llandudno on Thursday 4th February.

Members noted the initial response as drafted by the Clerk and these were generally accepted with the addition that the City Council supported three Counties in North Wales as described in the proposals.

RESOLVED that with the above amendment the response as drafted, be adopted as the City Council's official response to the consultation, and that the Town Clerk submit this to Welsh Government prior to the deadline date.

181/15 TCP UPDATE

The Town Clerk reported the latest position with regards to the Town Centre Partnership and the work that had been undertaken since the last meeting of the committee. Members noted that a Consultant had been engaged to help commission the aims and objectives of the TCP which included the setting up of an over-arching Board to be known as the City Centre Partnership which would meet three times a year and consisted of the strategic stakeholders. This would be supported by a Management Group which met approximately 6 times a year and consisted of the influencing and impacted stakeholders and beneath this level there would be three Thematic Sub Groups consisting of Business Economy Marketing and Promotion, Housing Health and Wellbeing, and Development and Environment sub group.

The Clerk explained that there were several schemes ongoing at the same time and a consultation process would shortly be underway engaging a large group of people and organisations, workshops together with an electronic survey which would be widely circulated.

The Clerk reminded Members that the Council at its meeting held on 11th January had suggested that the Office of Mayor, together with Councillor Susan Ashworth be appointed as additional representatives on the Partnership, it was now suggested this should be extended to the Deputy Mayor.

RESOLVED that the Mayor, Deputy Mayor and Councillor Ashworth be appointed to serve as the City Council's representatives on the TCP.

182/15 INVOICES FOR PAYMENT

It was **RESOLVED** that the invoices as detailed on the schedule totalling £14,225.63 be approved and passed for payments.
