## **87/18 PRESENTATION BY THE SAUDI ARABIAN GROUP**

Members received a presentation by the Bangor Saudi Group which outlined their history and links to the Bangor area. The presentation focused on the image of Saudi Arabia and its improving links with the UK.

The Group had agreed to meet with the City Council in an attempt to forge a good working relationship and presented four initiatives to engage with the Community of Bangor both financially and partnership.

Members thanked the Group for their presentation and asked that further engagement be made via a smaller group through the Town Clerk.

The Town Clerk gave details of a letter received from the Rotary Club of Bangor regarding the “Purple 4 Polio” campaign which included the lighting in purple of the Menai Straits from Caernarfon to Beaumaris.

The City Council was requested to do what it was able to with regards the lighting up the Pier in purple. The Town Clerk as asked to ascertain what could be done in the current circumstances and report back on the likely cost of the floodlighting.
