**C19/1068/11/LL** Conversion of previously used University building into 6 self-contained residential units and additional car parking space. Neuadd Ogwen, Normal College Of Education, College Road. **No objection.**

**C19/1078/DT** Application for the erection of a single storey flat roofed extension to the side of the property together with external alterations Collwyn, 1, Ffordd Cynan, Penrhosgarnedd. **No objection.**

**C19/1115/11/LL** New shop front and security shutter. 317 High Street. **No objection, 'The Council requests that the development take into account planning objections'.**

**C19/0993/11/LL** Create a parking space at front of property. 25 Pen y Wern **No objection.**

**C19/1072/11/LL** Residential Development of 30 Units (to include 12 affordable units) together with infrastructure, parking spaces, access, footpaths and amenity area. Land Of Pen Y Ffridd Road, Pen Y Ffridd Road, Penrhosgarnedd.

**Objection. The City Council object to this application in its current form on the following grounds:**

- i) **the percentage of affordable housing compared to properties at full market value is not in keeping with agreed parameters;**
- ii) **a reduction in road safety caused by the introduction of the proposed access road into the development from Pen y Ffridd Road. This road is frequently reduced to a single line of traffic due to parked vehicles and the consequential increase in traffic from this development will add to an already difficult driving area.**
