16/16 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below : -

C13/0156/11/LL Demolition of existing rear extension together with the erection of a part two storey and part single storey extension to the rear of the property, together with the provision of French doors and erect a new 1.8m fence by the right of way. 7 Glandwr Terrace, Bangor.

AND

C16/0440/11/CR Demolition of existing rear extension together with the erection of a part two storey and part single storey extension to the rear of the property. 7 Glandwr Terrace, Bangor

Objection on the grounds that some of the proposals will change the appearance of the Listed Building thus having a detrimental effect on the rest of the properties in this row of Listed Buildings.

C16/0252/11/HY Application to erect one external sign and one fascia sign. Menai Workshops, Lon Pobty, Bangor.
No Objections.

C16/0419/11/LL Erection of a two storey building to provide 4 self-contained apartments. Garages, Ffordd Craig y Don, Bangor.

C16/0421/11/LL Change of use of ground floor of existing dwelling house to Chaplaincy with flat above and installation of solar panels. Tegfryn, College Road, Bangor. **No objections however some reservations were expressed regarding the fixing of solar panels within a Conservation Area. Also concern was expressed about parking facilities given the Chaplaincy could attract many visitors.**

C16/0450/11/LL Erection of a rear and side extension. Bryn Ogwen, Siliwen Road, Bangor. **The City Council wish to have clarification as to whether the rear extension is included as this was not clear from the documentation submitted, it was therefore deferred until this information was forthcoming. The next meeting is on 6 June.**

C16/0456/11/CT Lop part of a lime tree and fell a juniper tree. St James Vicarage, 14 Ffriddoedd Road, Bangor. **No objections provided the Tree Officer is content.**

C16/0457/11/CR Demolish existing rear flat roof extension and erect new single storey extension, internal alterations and siting of new rooflight to the front. 9 Menai View Terrace, Bangor **No Objections.**

C16/0436/11/LL Erection of a A3unit (café) with drive-thru construction of parking spaces and two new vehicular access and felling of trees. **Objections as this is overdevelopment of the site, exacerbating the traffic problems at the roundabout and traffic flow. The quality of life and visually amenity would be reduced and detrimentally affected with the removal of so many trees.**
