#### **53/18 DRAFT FINAL ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2018**

Members considered the draft Audited Accounts for the year 2017/18 and the Internal Auditor's Report which had been circulated together with the Annual Governance Statement.

Several questions were raised about the figures and the implications of the Capital spend against the Revenue spend. The process for signing off the accounts and the statements was explained by the Town Clerk.

**RESOLVED:** To recommend to the Special Council Meeting the following:-

- (a) Approval of the Statement of Accounts 2017/2018;
- (b) Approval of the figures for the Annual Return 2017/2018;
- (c) Approval of the responses within the requirements of the Statement of Assurance 2017/2018

Members accepted the responsibility of the preparations of the accounts for the year ending 31 March 2018 and confirmed that they agreed with all the statements indicated in the documentation.

#### **54/18 PIER UPDATE**

The Town Clerk reported progress on the Pier Restoration Project and gave details of the proposed schedule of works to be undertaken at the Pier head. Also reported was the inspection made by representatives of the Marine Enforcement Body of Welsh Government, for which the City Council had received praise for its protection of the environment and the quality of the site operations.

He also reported upon the financial position, including budget, commitments, projections and suppliers. The current and projected expenditure schedules had been received and approved by the Financial Approvers under Standing Orders.

**RESOLVED:** that the report be received, noted and the details including the financial update be approved.

#### **55/18 FOOTBALL PITCH & CHANGING ROOMS**

The Town Clerk reported correspondence that had been received from Gwynedd Council regarding the future management and responsibilities for the Football Pitch and changing rooms at Beach Road.

Members commented that this area was protected as a "King George V Playing Field" and as such clarity on its formal upkeep was required.

Although the request was not to make any formal commitment it was asking if the City Council would partake in a working group to hold preliminary discussions and carry out a feasibility study. Prior to any interaction by the City Council, clarification was needed as to the status of the field vis a vis "King George V Playing Field" and what Gwynedd Officers had in mind when future management was mentioned.

**RESOLVED:** that the Town Clerk pursue these areas with Gwynedd Council and report back to a future meeting of the Council.

**56/18 CAR PARK SCHEME**

The Town Clerk reminded the Committee of previous discussion on this scheme, whereby 10% of car parking receipts could be passed on to the City Council from Gwynedd car parks within its boundaries in order to be spent on projects that were positive in terms of Environment, Social or Economic.

After some debate on the positives and negatives of the scheme it was recognised that further debate would be required as to what the additional monies could be spent on and how this would be presented publicly.

**RESOLVED:** that the Town Clerk circulate the full details of the scheme to all Members in order to have a full debate at the next meeting of any Committee of the Council.
