The Council refers to its previous observations from the Planning Committee meeting of 23 November 2020 (see below). The Council still has significant road safety concerns regarding the proposal. The Council also notes that its previous observations have not been noted in any documentation by Gwynedd Council:

The City Council do not object to this as a concept. However, it does have some concerns about the increased traffic that this application will generate, both to Caernarfon Road, in general, and to the country road that will be used for entry and egress. Is it possible to consider an alternative plan for access? This area of the City also suffers with excess waste. Can you request that the applicant consider incorporating a system were vehicle registrations numbers are printed on the take-out bags, as has been adopted by some fast food outlets?
